Our day program worked hard this year to re-establish volunteer opportunities that enhance the lives of the people served as well as the community. The production area at Headwaters Inc. continues to subcontract work for local businesses as well as provide confidential shredding. We are blessed to have worked with so many people to become assets to their community.

Headwaters Inc. in home support program is serving more individuals living independently. This program has expanded to serve individuals one hour per week all the way to 24 hour per day through the new Community Supported Living service. In home services allow the people we serve to be as independent as possible and enjoy their community.

As we transitioned leadership this year with our previous director moving back to her hometown, our team was able to work with Catholic Charities Bureau (CCB) affiliates to enhance programming and learn from one another. # Work Services

### Supported Living Services

Residential/Supported Living Services are designed to maximize a person's ability to manage everyday life skills in their homes and within their communities. These services can range from a few hours a week to 24/7 supports.

In 2021 Supported Living Services served

- 10 Supported Home Care participants
- 1 Community Supported Living participant •
- 3 24/7 residential participants.

## **Community Supported Employment**

Headwaters Inc. Community Supported Employment supports individuals in a wide range of meaningful opportunities to address individual needs and goals. Community Supported Employment is designed to maximize the person's ability to manage work activities in their community.

- We served 67 individuals with meaningful employment, mostly in Oneida and Vilas counties.
- Over the course of the year, Community Coaches provided active, purposeful support and used strategies to build relationships and natural supports with employers.
- Individuals enjoyed being able to try different work experiences with employers to decide if they liked the job or wanted to try something new.

Work Services provides training in soft skills and other work skills that lead to successful employment in our work area and in the community. Work services provides a variety of jobs in our production area that help participants develop necessary skills for employment.

- Work Services included 42 participants in the work area.
- 11 individuals worked out in the community.
- Participants cleaned at the National Guard Armory.
- Participants also worked on cleaning, building maintenance, and lawn care at 6 waysides in Forest, Oneida, and Vilas Counties.
- In addition, Headwaters maintains Wisconsin Valley Improvement sites in Lincoln County, several boat landings, the Wisconsin Department of Transportation, and their sign shop.
