Community Integration...Choices That Educate, Inspire, and Are Fun!

Participants have a variety of programs to choose from in Headwaters' Community Integration Program. These programs are: RCS (Recreation, Community Use, Social Behavior), FCPH (food preparation, clothing care, personal maintenance, home living), Older American, and Sensory. The following is a brief description of each segment of the programs:

RCS (Recreation, Community Use, Social Behavior)

Mary Freudenberg, Program Assistant, coordinates this active, on-the-go recreational program. This summer the participants enjoyed numerous field trips including Jim Peck's Wildlife Park, Northern Lights Playhouse, Children's Museum in Eagle River, Wisconsin River Cruise, Kovac Planetarium, Northwoods Petroleum Museum, Three Lakes Winery, Double "K" Trolley, Northwoods Wildlife Center, Vilas County Historical Museum, and visits to area parks. They also enjoyed swimming at the YMCA, bowling, fishing, and going to the Rhinelander District Library. The goal of *Community Use* is for participants to learn how to pay bills, identify various signs (stop/go, yield, walk/do not walk), learn the location of various area stores and businesses and the products/services they offer. Several tours were taken at the post office, grocery stores and florists. Learning proper social behavior is taught by going to various businesses and practicing good manners. Participants are taken to restaurants and shown how to order from a menu, pay for their food, and eat their food properly.

FCPH (food preparation, clothing care, personal maintenance, home living)

When you walk through Headwaters and smell the wonderful aroma of home cooking, you will find Judy Loew, Program Assistant, teaching the very popular *food preparation* class. Judy teaches menu preparation, selection/purchasing of nutritious food, and cooking delicious meals. In addition to *food preparation*, participants are taught how to care for their clothing (using the washing machine and dryer), *personal maintenance* (good hygiene, brushing their teeth, washing their hair and face, and taking care of their nails). In *home living* classes participants learn how to keep their home in good order by vacuuming/washing floors, dusting furniture, and cleaning dirty dishes.

Older American Program

The Older American Program is offered to participants who are 45 years or older and want to enjoy slower paced activities. Cheryl Hass, Program Assistant, supervises the many choices available, such as watching a movie, preparing and enjoying a snack and coffee, reminiscing about the past, and going for lunch at the Senior Center. They recently started an Advice Column where questions are posed to the group. A recent question submitted was: "Dear Older Americans: Who Should be Elected President of the United States?" They polled the Older Americans who dared get political... the outcome of their poll is posted at Headwaters.

Sensory Program

The Sensory Program is offered to those participants who need help improving their fine and gross motor skills and/or improve their ability to self-help. An individualized plan is developed and an Occupational Therapist is used as a consultant to set up sensory diets for each individual in the program. We recently purchased specialized equipment; such as, ladder lights, an activity wall, a touch screen computer monitor, acrylic mirrors, laser stars, weighted blankets, glider rockers, and a recliner for the sensory program with funds donated by Saint Mary's Hospital Ministry Fund (\$3,000), the Stephen G. Martin Memorial Fund (\$1,000), and Barbara & Harold Nehring (\$364.97). Special thanks to them for their generosity.



From the Director..

Providing possibilities for people with disabilities has always been our mission at Headwaters, Inc. Our goal is to help people develop the confidence needed to learn new work and life skills, try new experiences, and to give people an opportunity to make choices.

In 2009 Headwaters Inc. will be celebrating their 40th anniversary. We have a proud history of providing quality services to individuals with disabilities. As an agency, we have participated in many workgroups, committees, and partnered with many agencies and businesses for the betterment of services for people with disabilities. In

February of 2006 Governor Jim Doyle announced his goal to expand the Family Care Program in Wisconsin. According to the State, this program will give the people we serve better choices about where they live and what kinds of services and supports they need to meet their needs.

I would like to take this opportunity to encourage our readers to go on the internet and type in "Family Care." This is the new long-term redesign for Wisconsin. If you have a family member or you care for a person with a physical disability, developmental disability, or frail elderly you will want to learn more about this new initiative to expand managed long-term care in Wisconsin. By 2011, Governor Doyle is asking all counties to be involved in "Family Care." The new system will eliminate waiting lists and reorganize our long-term care system to meet the needs of our most vulnerable population. The way we do business will change and educating ourselves before those changes occur will help create a smooth and seamless transition.

I would also like to take this opportunity to introduce Jill Galarowicz. Jill is the Manager of our Sensory Program and The Caring Connection. Jill has an associate degree in nursing and she is also a social worker. Jill will be case managing, working with an Occupational Therapist on sensory diets, and developing therapeutic activities to assist our participants who suffer from early dementia or Alzheimer's. Headwaters is very fortunate to have a person with a medical and social work background join our team.

Headwaters' Transportation Department has been extremely busy this year. Julie Deaton, Transportation Coordinator, is receiving training to become a certified Mobility Manager. She has been coordinating and partnering with tri-county agencies to implement a more efficient and effective transportation system for people with disabilities and the elderly in the tri-county area. Headwaters is one of four agencies in the United States that will receive technical assistance to help rural communities enhance economic growth and development by improving transportation services throughout the tri-county area.

Open House a Great Success

An Open House was held at the First Congregational Church on September 5th to reintroduce The Caring Connection Adult Day Services to the community. This program is a State-licensed adult community-based respite care program designed to meet the needs of mature adults with memory loss who need minimal assistance with daily activities. Jill Galarowicz, Manager of The Caring Connection, reports the Open House was a great success. Several individuals and families learned more about the program. In addition, two ladies expressed their interest in volunteering for the program. For more information about this program or to volunteer, call Jill at 369-1337.

If you're a dog owner, you know how much fun your dog has playing with their beloved toy. The participants who work in Headwaters' Production Area 2 are excited knowing the Berber dog toys they create add to a dog's happiness. Deanna Barlow, Production Supervisor, says Headwaters supplies Drs. Foster & Smith with approximately 1,500 stuffed Berber dog toys every month. She further explains the process of how these dog toys are made: The Berber fabric pieces, which are cut out in various shapes (bear, rabbit, bone, dog) and purchased from Jacquart Fabric Products, are sewn together, inside out. Participants then turn the fabric right side out, stuff the toy with fiberfill, and insert a squeaker. After the final seam is sewn shut, any lint is brushed from the toy before the final product is shipped to Drs. Foster & Smith where they

are sold in their catalog and on their internet website. Drs. Foster & Smith and their staff are avid supporters of Headwaters and people with disabilities. In fact, they were presented with the Headwaters Foundations' 2007 Partnership Award. This award recognizes a business that provides significant sub-contract work to Headwaters and goes to great lengths to help people with disabilities remain employed at Headwaters.


