Welcome Jennifer Felty - New Director of Headwaters Inc.



2013 seems to be the year of transition for Headwaters. Among all the usual transitions throughout the year, Director Mary Hardtke retired in August after 13 years leading Headwaters. Catholic Charities hired Jennifer Felty to replace Ms.

Hardtke, and Jennifer began with the organization in mid-August. In September 2013, Headwaters said farewell to Mike Piazza, Production Manager, who retired from the organization after 39 years. Both Mary and Mike were honored with retirement parties to celebrate all they accomplished during their time with Headwaters and to thank them for their dedicated service to the organization.

The collaboration between Headwaters, Nicolet College, and the local school districts to develop college courses for people with intellectual disabilities has strengthened considerably over the last year. Exciting developments including Nicolet College offering two classes for people with intellectual disabilities at the college in the spring and then one class in the fall. Also, representatives from all of the collaborating agencies gathered together to participate in a planning session related to the project that was facilitated by a representative from Nicolet College. From that initial planning session, small work groups have been meeting to work on parts of the

plan, and the larger group gathered again in mid-August to follow up. There will be ongoing meetings with both the small groups and the larger group to continue to develop this exciting program that will open up many new opportunities for people with intellectual disabilities in our region.

Headwaters has also been working with UW-Whitewater's Center for Innovation & Business Development to assist the organization in identifying possible new revenue streams and to develop better marketing strategies in general. This work correlates directly to the Headwaters Strategic Planning goal of expanding revenue streams. UW-Whitewater is able to provide these services through a grant they have, and we're very grateful to be able to benefit from their expertise.

One of the other Headwaters Strategic Planning goals was "Telling Our Story," and to that end Headwaters staff have given or participated in 130 tours over the past year-most of the tours were at Headwaters, but they also included Headwaters staff and participants touring other area businesses. There have already been a number of great things that have happened as a result of these tours, as people get to see first-hand the valuable work that Headwaters does.

Recently, Trig's Smokehouse was looking for a person to assemble boxes for them. Because Ross already had the skills he learned from assembling boxes at Headwaters, we knew this would be a great opportunity for both Ross and Trig's Smokehouse.

Ross began with a four week temporary work experience. During that time, he mastered the skill of making several different types of meat boxes. At the conclusion of the temporary work, the Manager recognized that Ross was such a great asset to the team and was able to hire him as a permanent employee. Ross is now able to work independently at his job because of the wonderful support system he has developed with his supervisors and co-workers.

This turned out to be a win-win situation for Ross and Trig's Smokehouse. The community employment staff at Headwaters holds such high value to the businesses in the area. While times are tough, we have found many businesses willing to open their doors to help people with disabilities. We would like to thank Trig's Smokehouse for providing such a wonderful opportunity for Ross. PRODUCTION

In July Headwaters secured a new contract with the Wisconsin Valley Improvement Company to maintain two boat landings with bathrooms at the Nekomis Reservoir and Rice Reservoir. The job includes maintaining the grounds and cleaning the restrooms. The Oneida County RAM (Rest Area Maintenance) crew is covering these sites this year. We are also looking at three additional sites for next year - Rainbow, Spirit, and Lake Mohauksin Reservoirs. We are thankful to the Wisconsin Valley Improvement Co. for this opportunity.

We were delighted to have seven students attend Headwaters this summer. One of the students, Aaron, told us the best part of summer was the shopping skills he learned along with playing the Wii. We started a new "Technology and Theater" class this summer and taught two photography and gardening classes.

Several of the pictures taken during the photography classes were entered in the Nicolet Gallery contest and one received an Honorable Mention. We will be entering more photos into two more upcoming shows.

This year the gardening class explored "straw bale gardening." It was a huge success! In the spring the class sowed the tomato seeds. Once the plants were large enough, they transplanted them into the straw bales. The "Getting Fit" class assisted with watering the plants. As a result, we have 18 tomatoes on the three plants. Once the tomatoes are ripe, the gardening group will make a tomato salad to present to our new Director, Jennifer.
