

Today Cindy advocates for other people with disabilities and helped to start People First Wisconsin, which is a statewide arassroots non-profit self-advocacy organization run by and for people with disabilities. Through education and advocacy, People First Wisconsin helps people to start and support local groups and to work together with self-advocates across Wisconsin on issues that are important. They collaborate with other advocacy groups in Wisconsin to encourage change and to be an important part of the decisions that affect people with disabilities in Wisconsin.

People First Wisconsin is committed to challenging the institutions, social policies, and community attitudes that discourage individuals with disabilities from achieving their full potential. In the coming months we have identified several activities in the community and at Headwaters to teach the people we support to better achieve their full potential and

be more active in their community.

Our second opportunity was working with leaders in the field of personcentered planning. We are embracing this concept at Headwaters, Inc. with surprising and

Tom VanBeek of the Wisconsin Department of Transportation presented the **Governor's Appreciation Award** to Headwater's Rest Area Maintenance (RAM) crew on September 4th. Headwaters has contracted with the Wisconsin Department of Transportation to provide custodial care and landscaping maintenance services at seven sites located throughout Oneida, Vilas, Forest, and Lincoln counties. The goals of the RAM program are to provide the best maintained roadside facilities in the nation and to provide maximum employment opportunities to people with disabilities. Headwater's four RAM supervisors train and supervise 16 individuals with disabilities on their custodial and landscape maintenance crews. Services provided by Headwaters RAM crews include cleaning and buildings (including minor repairs and painting) and mowing the grounds. Rehabilitation for Wisconsin (RFW) works with the Wisconsin Department of Transportation and Headwaters to ensure that quality services are provided at each site. Congratulations!


