#### The Power of Association

In May, we held a series of meetings with guardians and family members of people served by Headwaters to talk about the changing landscape of services for people with disabilities in Wisconsin and around the country.

A number of people with disabilities and family members are aware of national activity aimed at redirecting day and work services: agreements between states and the Department of Justice to phase out sheltered workshops and move toward community jobs and other forms of community participation; lobbying by a number of advocacy groups to repeal the provision of Labor Law that allows payment of sub-minimum wages to some people with disabilities; and instructions to state vocational rehabilitation agencies that require funds for young people in transition to focus on community jobs or further education before placement in sheltered workshops or day services.

Family members say that individualized supports for community employment, volunteering, college and other community involvements are desirable for the people who can safely do these things with the resources available. They are happy for those people who have demonstrated that, with the right support, they can do all these good things. Their concern is that attending too much to those who are successful will lead to failures for family members who can't succeed in the community and need the structure, protection and relationships provided by sheltered work and day services. They also want to assure that the benefits of belonging and friendship that come with attendance at Headwaters are preserved.

The meetings with families were co-hosted by people that Headwaters serves who are exploring new possibilities. One attends the Nicolet College Jump! Start program and is enrolling as a student at

Edgewood College in the Fall. Another works at Trigs. A third is enrolled in regular studies at Nicolet College. A fourth is doing an internship in an early childhood program. Each co-host made a short presentation. Together they made these important points.

- Many younger people have different experiences than older people with developmental disabilities have had, including good opportunities to learn from their earliest years. Many of them have high expectations for themselves and for the services that support them. They want to work and make a contribution to their community. They are advocates for themselves.
- Each of them is now doing something that had seemed like a dream to them. Finding their way to move forward has meant overcoming fears and learning. It couldn't happen without positive people who believe in you, especially when it looks like you might fail.
- You can learn and get stronger from things that don't work out.
- Some people are prejudiced against people with disabilities. You can deal with what they try to do to you if you know there are people on your side. You can't let prejudiced people run your life.
- People have access to technology and forms of support that were not available to older people with developmental disabilities; this makes many more things possible.
- Each person is pursuing different interests with different goals. Jobs and studies need to be customized to fit.
- People can start with a small step and build on it. It's important to try because trying something new puts you in a place where you can learn what your next steps are.
